
# CARE4 MODULE NAME: Web ED and EDM BPMH and Admission

### Overview

The admission process flow in ED works <u>most efficiently</u> if a Best Possible Medication History is completed prior to Admission being completed. This is because the Admitting physician can choose whether the home medications should be <u>Stopped, Continued,</u> <u>or Held</u> during their inpatient visit.

Ideal Workflow below:



#### **Current Issue**

- Home medications are not being actioned (stopped, continued, or held) in the Manage Transfer because the BPMH has not been completed prior to the Manage Transfer being initiated
- Patients have a delay in receiving their home medications if they are not addressed at the point of admission
- The BPMH would need to be retroactively completed by a pharmacy tech

### If an admission is anticipated prior to an admission occurring:

- 1. Nursing can request a BPMH
- 2. Physician can request a BPMH

Note: If a Pharmacy Tech anticipates admission, they can complete it without receiving the request from a physician or nurse
